# Quantum Euler class and virtual Tevelev degrees of Fano complete intersections

#### Abstract

We compute the quantum Euler class of Fano complete intersections $X$ in a projective space. In particular, we prove a recent conjecture of A. Buch and R. Pandharipande, namely [7, Conjecture 5.14]. Finally we apply our result to obtain formulas for the virtual Tevelev degrees of $X$. An algorithm computing all genus 0 two-point Hyperplane Gromov-Witten invariants of $X$ is illustrated along the way.

## 1. Introduction

### 1.1. Quantum Euler class of a variety

Let X be a nonsingular, projective, algebraic variety over $\mathbb{C}$ of dimension $r$ and let $\left\{\gamma_{j}\right\}_{j=0}^{N} \subset H^{*}(X)$ be a homogeneous basis with $\gamma_{0}=1$ and $\gamma_{N}=\mathrm{P}$ the point class. The small quantum cohomology ring $Q H^{*}(X)\left({ }^{1}\right)$ of $X$ is defined via the 3-point genus 0 Gromov-Witten invariants:

$$
\gamma_{i} \star \gamma_{j}=\sum_{\beta \in H_{2}(X, \mathbb{Z})} \sum_{k}\left\langle\gamma_{i}, \gamma_{j}, \gamma_{k}^{\vee}\right\rangle_{0, \beta}^{X} q^{\beta} \gamma_{k}
$$

where $\gamma_{k}^{\vee} \in H^{*}(X)$ is the dual of $\gamma_{k}$ with respect to the intersection form on $X$, defined by the conditions

$$
\int_{X} \gamma_{j} \cup \gamma_{k}^{\vee}=\delta_{j, k} \quad \text { for } j=0, \ldots, N
$$

Here we are following the notation of [14].
Let also

$$
\Delta=\sum_{j} \gamma_{j}^{\vee} \otimes \gamma_{j} \in H^{*}(X) \otimes H^{*}(X)
$$

be the Künneth decomposition of the diagonal class of $X \times X$.
The quantum Euler class of $X$ is the image of $\Delta$ under the product map

$$
H^{*}(X) \otimes H^{*}(X) \xrightarrow{\star} Q H^{*}(X) .
$$

This is a canonically defined element of $Q H^{*}(X)$, first introduced by Abrams in [2]. In terms of the basis $\left\{\gamma_{j}\right\}$, we have

$$
\mathrm{E}=\sum_{j} \gamma_{j}^{\vee} \star \gamma_{j}
$$

Note that in particular

$$
\mathrm{E} \equiv \chi(X) \mathrm{P} \bmod q
$$

where $\chi(X)$ is the Euler characteristic of $X$.
In this paper we compute the quantum Euler class of all Fano nonsingular complete intersections of dimension at least 3 in a projective space (see Theorem 5 below). In particular, we prove a conjecture of Buch-Pandharipande, namely [7, Conjecture 5.14].
$\left.{ }^{(1}\right)$ Unless otherwise specified, (co)homology and quantum cohomology will always be taken with $\mathbb{Q}$-coefficients in this paper.

It is worth noting that although a priori the definition of $E$ involves also the primitive cohomology of $X$, in our case of interest, this class actually lies in the restricted quantum cohomology ring $Q H^{*}(X)^{\text {res }}$ of $X$, that is the quantum cohomology ring coming from the projective space (see Proposition 1 below for the exact definition of $\left.Q H^{*}(X)^{\text {res }}\right)$. This is a key reason we were able to obtain so explicit a formula for E .

Finally, in [7] the quantum Euler class E of any variety $X$ is related via a very simple formula (see [7, Theorem 1.4]) to the virtual Tevelev degrees of $X$, that is the virtual count of genus $g$ maps of fixed complex structure in a given curve class $\beta$ through $n$ general points of $X$. Exploiting their formula and our explicit expression of E for $X$ a Fano nonsingular complete intersection of dimension at least 3, we are able to compute all the virtual Tevelev degrees of such varieties $X$ (see Theorem 10 below).

### 1.2. Preliminary results on complete intersections

We now specialize to smooth complete intersections of dimension at least 3 . Let $X=V\left(f_{1}, \ldots, f_{L}\right) \subset \mathbb{P}^{r+L}$ be a nonsingular complete intersection of dimension $r$. Assume for the rest of the paper that $r \geq 3$ and that for $i=1, \ldots, L$,

$$
f_{i} \in H^{0}\left(\mathbb{P}^{r+L}, \mathcal{O}\left(m_{i}\right)\right)
$$

where $m_{i} \geq 2$.
Let $\mathrm{m}=\left(m_{1}, \ldots, m_{L}\right)$ be the vector of degrees and, for $a, b \in \mathbb{Z}$ adopt the following notation:

$$
|\mathrm{m}|=\sum_{i=1}^{L} m_{i}, \quad \mathrm{~m}^{a \mathrm{~m}+b}=\prod_{i=1}^{L} m_{i}^{a m_{i}+b} .
$$

### 1.2.1. Cohomology of complete intersections

Consider the map

$$
\begin{equation*}
H^{i}\left(\mathbb{P}^{r+L}\right) \longrightarrow H^{i}(X) \tag{1}
\end{equation*}
$$

induced by the inclusion $X \subset \mathbb{P}^{r+L}$. By the Lefschetz Hyperplane Theorem, this map is an isomorphism for all $i \leq 2 r, i \neq r$ and is injective for $i=r$. Also, for $i=r$, we have a canonical decomposition

$$
H^{r}(X)=H^{r}(X)^{\text {prim }} \oplus H^{r}(X)^{\text {res }}
$$

as a direct sum of the primitive cohomology and the restricted cohomology of degree $r$.

Explicitly

$$
H^{r}(X)^{\mathrm{res}}=\operatorname{Im}\left(H^{r}\left(\mathbb{P}^{r+L}\right) \longleftrightarrow H^{r}(X)\right)
$$

and

$$
H^{r}(X)^{\text {prim }}=\operatorname{Ker}\left(\mathrm{H} \cup-: H^{r}(X) \longrightarrow H^{r+2}(X)\right)
$$

where $\mathrm{H} \in H^{*}(X)$ is the hyperplane class.
Note that

$$
\operatorname{dim} H^{r}(X)^{\text {prim }}=(-1)^{r}(\chi(X)-(r+1))
$$

where $\chi(X)$ is the Euler characteristic of $X$.

### 1.2.2. Quantum cohomology of Fano complete intersections

From now on, we will further restrict our attention to the Fano case

$$
\begin{equation*}
|\mathrm{m}| \leq r+L \tag{2}
\end{equation*}
$$

Since $r \geq 3$, the map in Equation 1 is an isomorphism when $i=2$ and thus

$$
H_{2}(X)=\mathbb{Q} \cdot \mathrm{L}
$$

where $\mathrm{L} \in H^{*}(X)$ is the class of a line in $X$. It follows that $Q H^{*}(X)$ is a graded algebra over the polynomial ring $\mathbb{Q}[q]$ in one variable $q$ and as $\mathbb{Q}[q]$-modules we have

$$
Q H^{*}(X)=H^{*}(X) \otimes_{\mathbb{Q}} \mathbb{Q}[q]
$$

The degree of $q$ is equal to $2 d$ where

$$
d=r+L+1-|\mathrm{m}| .
$$

which is greater than 0 by Equation 2.
Depending on the degree $|\mathrm{m}|$ of $X$, the ring $Q H^{*}(X)$ satisfies the following magic relation (due to A. Givental):

- if $|\mathrm{m}| \leq r+L-1$ we have:

$$
\begin{equation*}
\mathrm{H}^{\star(r+1)}=\mathrm{m}^{\mathrm{m}} q \mathrm{H}^{\star(|\mathrm{m}|-L)} \tag{3}
\end{equation*}
$$

- if $|\mathrm{m}|=r+L$ we have:

$$
\begin{equation*}
(\mathrm{H}+\mathrm{m}!q)^{\star(r+1)}=\mathrm{m}^{\mathrm{m}} q(\mathrm{H}+\mathrm{m}!q)^{\star r} \tag{4}
\end{equation*}
$$

Some cases of Equation 3 are proved in [3]. A complete proof of both relations can be found in Givental's paper [15]. There also are two very nice expositions of Givental's work, see [22, Section 3.2] and [6, Corollary 4.4 and Corollary 4.19]. Relations 3 and 4 will be essential for the object of this paper.

### 1.3. Statement of the main theorem

In Theorem 5 below we will give explicit formulas for the quantum Euler class of any smooth Fano complete intersection $X \subseteq \mathbb{P}^{r+L}$ as above. Much of our work starts with the results in [7], some of which we now recall for the reader's convenience.

Proposition 1. (due to T. Graber) Let $\mathrm{R}=\operatorname{Span}\left\{1, \mathrm{H}, \ldots, \mathrm{H}^{r}\right\} \subset H^{*}(X)$. Then, $\left(\mathrm{R} \otimes_{\mathbb{Q}} \mathbb{Q}[q], \star\right)$ is a subring of $Q H^{*}(X)$.

Proof. This is [7, Proposition 5.1].
This ring is denoted by $Q H^{*}(X)^{\text {res }}$.
Remark 2. The elements $1, \mathrm{H}, \ldots, \mathrm{H}^{\star r}$ form a basis of $Q H^{*}(X)^{\text {res }}$ as $\mathbb{Q}[q]$-module. This follows from the fact that $\mathbf{H}^{i}=\mathrm{H}^{\star i} \bmod q$ and $\mathrm{H}^{\star i} \in Q H^{*}(X)^{\text {res }}$ for $i=0, \ldots, r$.

Let E be the quantum Euler class of $X$.
Lemma 3. We have $\mathrm{E} \in Q H^{*}(X)^{\mathrm{res}}$.
Proof. See [7, Proof of Proposition 5.5].
By Remark 2 and Lemma 3, we can uniquely write

$$
\mathrm{E}=\sum_{i=0}^{\left\lfloor\frac{r}{d}\right\rfloor} \operatorname{Coeff}\left(\mathrm{E}, q^{i} \mathbf{H}^{\star(r-i d)}\right) q^{i} \mathbf{H}^{\star(r-i d)}
$$

where $\operatorname{Coeff}\left(\mathrm{E}, q^{i} \mathbf{H}^{\star(r-i d)}\right) \in \mathbb{Q}$. Our goal is to make this coefficients explicit.
Remark 4. We have

$$
\operatorname{Coeff}\left(\mathrm{E}, \mathrm{H}^{\star r}\right)=\mathrm{m}^{-1} \sum_{j} \int_{X} \gamma_{j}^{\vee} \cup \gamma_{j}=\mathrm{m}^{-1} \sum_{j}(-1)^{\operatorname{deg}\left(\gamma_{j}\right)}=\mathrm{m}^{-1} \chi(X)
$$

The main result of the paper is the following:
Theorem 5. (Main Theorem) The following equalities hold:

- if $|\mathrm{m}| \leq r+L-1$ then

$$
\mathrm{E}=\mathrm{m}^{-1} \chi(X) \mathrm{H}^{\star r}+(r+L+1-|\mathrm{m}|-\chi(X)) \mathrm{m}^{\mathrm{m}-1} q \mathrm{H}^{\star|\mathrm{m}|-L-1}
$$

- if $|\mathrm{m}|=r+L$ then

$$
\mathrm{E}=\mathrm{m}^{-1} \chi(X) \mathrm{H}^{\star r}+\sum_{j=1}^{r} \mathrm{~m}^{-1}(j-\chi(X))\binom{r}{j-1}(\mathrm{~m}!)^{j-1}\left[\mathrm{~m}^{\mathrm{m}}-\frac{\mathrm{m}!}{j}(r+1)\right] q^{j} \mathrm{H}^{\star r-j}
$$

The case $|\mathrm{m}| \leq r+L-1$ in the theorem is exactly [7, Conjecture 5.14] and is already shown to be true $\bmod q^{2}$ in [7, Corollary 5.13]. The proof of this theorem is given in Section 3.

### 1.4. Application: virtual Tevelev degrees of Fano complete intersections

### 1.4.1. Virtual Tevelev degrees

Let $X$ be a nonsingular, projective, algebraic variety over $\mathbb{C}$ of dimension $r$. Fix integers $g, n \geq 0$ satisfying the stability condition $2 g-2+n>0$ and fix $\beta \in H_{2}(X, \mathbb{Z})$ an effective curve class satisfying the condition

$$
\int_{\beta} c_{1}\left(T_{X}\right)>0 .
$$

Let $\overline{\mathcal{M}}_{g, n}(X, \beta)$ be the moduli space of genus $g$, $n$-pointed stable maps to $X$ in class $\beta$ and assume that the dimensional constraint

$$
\operatorname{vdim}\left(\overline{\mathcal{M}}_{g, n}(X, \beta)\right)=\operatorname{dim}\left(\overline{\mathcal{M}}_{g, n} \times X^{n}\right)
$$

holds. This is equivalent to

$$
\begin{equation*}
\int_{\beta} c_{1}\left(T_{X}\right)=r(n+g-1) . \tag{5}
\end{equation*}
$$

Let

$$
\tau: \overline{\mathcal{M}}_{g, n}(X, \beta) \longrightarrow \overline{\mathcal{M}}_{g, n} \times X^{n}
$$

be the canonical morphism obtained from the domain curve and the evaluation maps:

$$
\pi: \overline{\mathcal{M}}_{g, n}(X, \beta) \longrightarrow \overline{\mathcal{M}}_{g, n}, \quad \text { ev }: \overline{\mathcal{M}}_{g, n}(X, \beta) \longrightarrow X^{n}
$$

Then the virtual Tevelev degree $\operatorname{vTev}_{g, n, \beta}^{X} \in \mathbb{Q}$ of $X$ is defined by the equality

$$
\tau_{*}\left[\overline{\mathcal{M}}_{g, n}(X, \beta)\right]^{\mathrm{vir}}=\operatorname{vTev}_{g, n, \beta}^{X}\left[\overline{\mathcal{M}}_{g, n} \times X^{n}\right] \in A^{0}\left(\overline{\mathcal{M}}_{g, n} \times X^{n}\right)
$$

Alternatively, denoting by $\Omega_{g, n, \beta}^{X}: H^{*}(X)^{\otimes n} \rightarrow H^{*}\left(\overline{\mathcal{M}}_{g, n}\right)$ the Gromov-Witten class

$$
\Omega_{g, n, \beta}^{X}(\alpha):=\pi_{*}\left(\mathrm{ev}^{*}(\alpha) \cap\left[\overline{\mathcal{M}}_{g, n}(X, \beta)\right]^{\mathrm{vir}}\right)
$$

we have

$$
\operatorname{vTev}_{g, n, \beta}^{X}\left[\overline{\mathcal{M}}_{g, n}\right]=\Omega_{g, n, \beta}^{X}\left(\mathrm{P}^{\otimes n}\right)
$$

Fixed-domain curve counts for Grassmanians have a beautiful story at the intersection between algebraic geometry and physics. They are computed by the celebrated Vafa-Intriligator formula, conjectured by the physicists Vafa and Intriligator [16] and partially proved by Siebert-Tian [23] and by Bertram-DaskalopoulosWentworth in [4] and [5], and fully proven by Marian-Oprea in [20] using Quotschemes. The equivalence with the formulation in terms of stable maps was then proven by Marian-Oprea-Pandharipande in [21]. The systematic study of Tevelev
degrees for general targets started with [11], motivated by work of Tevelev [24] on scattering amplitudes in mathematical physics. The paper [11] then stimulated a series of subsequent studies. In [11] these degrees were formally defined and computed via Hurwitz theory for the case of $\mathbb{P}^{1}$; then, in [13], using Schubert calculus the problem was posed and solved for the case of $\mathbb{P}^{n}$; in $[10]$ a generalization of these degrees is presented for $\mathbb{P}^{1}$. In [7] a virtual perspective is adopted via Gromov-Witten theory and in [19] an equality between virtual and geometric Tevelev degrees is proven for certain Fano varieties and large degree curve classes. The relationship between virtual and geometric degrees is studied for point blow-up of projective spaces in [9], where the authors also provided simpled closed formulas for the Tevelev degrees of such varieties. In [18] geometric Tevelev degrees are computed for low degree hypersurfaces and large degree curve classes via projective geometry. Finally, a tropical perspective is presented in [8] where, after proving a generalization of Mikhalkin's correspondence theorem for logarithmic and tropical Tevelev degrees, the authors computed these degrees for Hirzebruch surfaces in genus 0 .

### 1.4.2. Virtual Tevelev degrees of Fano complete intersections

In this paper, we are concerned with exact computations of virtual Tevelev degrees of Fano complete intersections following the perspective presented in [7] and described above in Section 1.4.1.

Let $X$ be a smooth Fano complete intersection in $\mathbb{P}^{r+L}$ of dimension $r \geq 3$ and vector of degrees m . Writing $\beta=k \mathbf{L}$ with $k>0$, condition 5 becomes

$$
k=k[g, n]:=\frac{n+g-1}{d} r .
$$

For us, the main ingredient to compute $\operatorname{vev}_{g, n, k}^{X}$ will be the following result:
Theorem 6. Suppose $k=k[g, n]$. Then

$$
\operatorname{vTev}_{g, n, k}^{X}=\mathrm{m}^{1} \operatorname{Coeff}\left(\mathrm{P}^{\star n} \star \mathrm{E}^{\star g}, q^{k} \mathrm{H}^{\star r}\right)
$$

Proof. This is [7, Theorem 1.4].
Before stating our theorem, we require a remark and some additional notation.
Remark 7. Given the form of Equation 4, when $|\mathrm{m}|=r+L$ it will be more convenient to use $1,(\mathrm{H}+\mathrm{m}!q), \ldots,(\mathrm{H}+\mathrm{m}!q)^{\star r}$ instead of $1, \mathrm{H}, \ldots, \mathrm{H}^{\star r}$ as a basis of $Q H^{*}(X)$ as $\mathbb{Q}[q]$-module.

Definition 8. Define

$$
\mathbb{Q} \ni P_{i}= \begin{cases}\operatorname{Coeff}\left(\mathrm{P}, q^{i} \mathrm{H}^{\star r-i d}\right) & \text { when }|\mathrm{m}| \leq r+L-1, \\ \operatorname{Coeff}\left(\mathrm{P}, q^{i}(\mathrm{H}+\mathrm{m}!q)^{\star r-i}\right) & \text { when }|\mathrm{m}|=r+L,\end{cases}
$$

for $i=0, \ldots,\left\lfloor\frac{r}{d}\right\rfloor$ and

$$
\mathbb{Q} \ni b_{i}= \begin{cases}\operatorname{Coeff}\left(\mathrm{P}^{\star n} \star \mathrm{E}^{\star g}, q^{i+k} \mathrm{H}^{\star r-i d}\right) & \text { when }|\mathrm{m}| \leq r+L-1, \\ \operatorname{Coeff}\left(\mathrm{P}^{\star n} \star \mathrm{E}^{\star g}, q^{i+k}(\mathrm{H}+\mathrm{m}!q)^{\star r-i}\right) & \text { when }|\mathrm{m}|=r+L\end{cases}
$$

for $i=0, \ldots,\left\lfloor\frac{r}{d}\right\rfloor$.
Note that, by Theorem 6

$$
\mathrm{vTev}_{g, n, k}^{X}=\mathrm{m}^{1} b_{0}
$$

and that by Theorem 5 the $b_{i}$ 's are determined by the $P_{i}$ 's.
Definition 9. Following [7, Definition 5.15], we define the discrepancy of $\mathrm{P}^{\star n} \star$ $\mathrm{E}^{\star g}$ to be

$$
\operatorname{Disc}\left(\mathrm{P}^{\star n} \star \mathrm{E}^{\star g}\right)=\sum_{i=1}^{\left\lfloor\frac{r}{d}\right\rfloor} b_{i} \mathrm{~m}^{-i \mathrm{~m}+1}
$$

Putting everything together we obtain explicit formulas for all virtual Tevelev degrees of $X$ (once all the coefficients $P_{i}$ are known):

Theorem 10. Suppose $k=k[g, n]$. Then, the virtual Tevelev degrees of $X$ are as follows:

- if $|\mathrm{m}| \leq r+L-1$ then

$$
\mathrm{vTev}_{g, n, k}^{X}=\left(\sum_{i=0}^{\left\lfloor\frac{r}{d}\right\rfloor} P_{i} \mathrm{~m}^{-i \mathrm{~m}}\right)^{n}(r+L+1-|\mathrm{m}|)^{g} \mathrm{~m}^{k \mathrm{~m}-g+1}-\operatorname{Disc}\left(\mathrm{P}^{\star n} \star \mathrm{E}^{\star g}\right),
$$

- if $|\mathrm{m}|=r+L$ then

$$
\begin{aligned}
\operatorname{vTev}_{g, n, k}^{X}= & \left(\sum_{i=0}^{r} P_{i} \mathrm{~m}^{-i \mathrm{~m}}\right)^{n}\left(1-\mathrm{m}^{-r \mathrm{~m}}(\mathrm{~m}!)^{r}(r+1-\chi(X))\right)^{g} \mathrm{~m}^{k \mathrm{~m}-g+1} \\
& -\operatorname{Disc}\left(\mathrm{P}^{\star n} \star \mathrm{E}^{\star g}\right) .
\end{aligned}
$$

The case $|\mathrm{m}| \leq r+L-1$ already appears in [7, Proposition 5.16] (where they assume that $[7$, conjecture 5.14$]$ holds for $X$ ), the case $|\mathrm{m}|=r+L$ is instead completely new.

The last question would be if we can actually express the coefficients $P_{i}$ appearing in Theorem 10 in a closed formula, obtaining in this way a closed formula for the virtual Tevelev degrees.

Partial results have been obtained in [7], where they gave a complete answer in the following cases:

- for quadric hypersurfaces (see [7, Theorem 1.5 and Example 2.4];
- for low degree complete complete intersections $r>2|\mathrm{~m}|-2 L-2$ which are not quadrics (see [7, Corollary 5.11 and Theorem 5.19]);
- for the border case $r=2|\mathrm{~m}|-2 L-2$ (see [7, Lemma 5.21 and Corollary 5.23]). Here we will content ourselves with illustrating in Section 5 an algorithm that calculates all the coefficients $P_{i}$. It should be noted here that the method we will describe is more effective than the general result in [1], where they deal with Gromov-Witten invariants in all genera with arbitrary insertions.

## 2. A preliminary computation

We start with expressing $\mathrm{H}^{i}$ for $i=1, \ldots, r$ as a linear combination of $1, \ldots, \mathrm{H}^{\star r}$ with coefficients in $\mathbb{Q}[q]$.

The following notation will be convenient. For $k \geq 0$ and $0 \leq j \leq r$ let

$$
\alpha_{r-j}^{k}:=\mathrm{m}^{-1}\left\langle\mathrm{H}^{k d+j-1}, \mathrm{H}^{r-j}\right\rangle_{0, k}^{X}=\mathrm{m}^{-1} \int_{\left[\overline{\mathcal{M}}_{0,2}(X, k \mathrm{~L})\right]^{\mathrm{vir}}} \operatorname{ev}_{1}^{*} \mathrm{H}^{k d+j-1} \cup \operatorname{ev}_{2}^{*} \mathrm{H}^{r-j}
$$

where L is the class of a line in $X$ and $\mathrm{ev}_{i}: \overline{\mathcal{M}}_{0,2}(X, k \mathrm{~L}) \rightarrow X$ are the evaluation maps for $i=1,2$. Note the following symmetry:

$$
\alpha_{r-j}^{k}=\alpha_{k d+j-1}^{k}
$$

Proposition 11. Let $0 \leq i \leq r$. Then, for $1 \leq j \leq\left\lfloor\frac{i}{d}\right\rfloor$, we have
$\operatorname{Coeff}\left(\mathrm{H}^{i}, q^{j} \mathrm{H}^{\star(i-j d)}\right)=$

$$
=\sum_{\ell: 1 \leq \ell \leq j}(-1)^{\ell} \sum_{\substack{\left(i_{1}, \ldots, i_{\ell}\right) \in \mathbb{Z}_{\geq 1} \geq \\ i_{1}+\ldots+i_{\ell}=j}} \sum_{\substack{\left(u_{1}, \ldots, u_{\ell}\right) \in\left(\mathbb{Z}_{\geq 0}\right)^{\ell}, 0 \leq u_{\ell} \leq \ldots \leq u_{1} \leq i-j d}} \prod_{a=1}^{\ell} i_{a} \alpha_{r-\left(j-i_{1}-\ldots-i_{a}\right) d-u_{a}}^{i_{a}} .
$$

Proof. We proceed by induction on $i$.
When $i<d$ there is nothing to prove. When $i=d$, it follows that $j=1$ and the right-hand side of the equation is just $\alpha_{r}^{1}$. To compute the left-hand side note that $\mathrm{H}^{i}=\mathrm{H}^{\star i}$ for $i<d$ and thus

$$
\mathrm{H}^{\star d}=\mathrm{H} \star \mathrm{H}^{d-1}=\mathrm{H}^{d}+q\left\langle\mathrm{H}, \mathrm{H}^{d-1}, \mathrm{H}^{r}\right\rangle_{0,1}^{X} \mathrm{~m}^{-1} .
$$

Note that, since $\mathrm{H} \star \mathrm{H}^{d-1} \in Q H^{*}(X)^{\text {res }}$, the primitive cohomology contribution in $\mathrm{H} \star \mathrm{H}^{d-1}$ is 0 .

Use now the divisor equation in Gromov-Witten theory to obtain

$$
\left\langle\mathrm{H}, \mathrm{H}^{d-1}, \mathrm{H}^{r}\right\rangle_{0,1}^{X} \mathrm{~m}^{-1}=\alpha_{r}^{1} .
$$

Assume now that the Theorem is true for $i=d, \ldots, t-1<r$.
Write

$$
\mathrm{H} \star \mathrm{H}^{t-1}=\mathrm{H}^{t}+\sum_{k=1}^{\left\lfloor\frac{t}{d}\right\rfloor}\left\langle\mathrm{H}, \mathrm{H}^{t-1}, \mathrm{H}^{k d+r-t}\right\rangle_{0, k}^{X} \mathrm{~m}^{-1} q^{k} \mathrm{H}^{t-k d} .
$$

where again the primitive cohomology contributions in $\mathrm{H} \star \mathrm{H}^{t-1}$ is 0 and by the divisor equation

$$
\mathrm{m}^{-1}\left\langle\mathrm{H}, \mathrm{H}^{t-1}, \mathrm{H}^{k d+r-t}\right\rangle_{0, k}^{X}=k \alpha_{r-(t-k d)}^{k} .
$$

Note now that, by induction, we know how to write the $\mathbf{H}^{t-k d}$ and $\mathbf{H}^{t-1}$ in terms of $1, \mathrm{H}, \ldots, \mathrm{H}^{\star r}$. Putting everything together we obtain for $1 \leq j \leq\left\lfloor\frac{t}{d}\right\rfloor$

$$
\begin{aligned}
& \operatorname{Coeff}\left(\mathrm{H}^{t}, q^{j} \mathrm{H}^{\star(t-j d)}\right) \\
& =\operatorname{Coeff}\left(\mathrm{H}^{t-1}, q^{j} \mathrm{H}^{\star(t-1-j d)}\right)-\sum_{k=1}^{j} k \alpha_{r-(t-k d)}^{k} \operatorname{Coeff}\left(\mathrm{H}^{t-k d}, q^{j-k} \mathrm{H}^{\star(t-j d)}\right) \\
& =\sum_{\ell=1}^{j}(-1)^{\ell} \sum_{\substack{i_{1}+\ldots+i_{\ell}=j, 0 \leq u_{\ell} \leq \ldots \leq u_{1} \leq t-1-j d}} \prod_{a=1}^{\ell} i_{a} \alpha_{r-\left(j-i_{1}-\ldots-i_{a}\right) d-u_{a}}^{i_{a}} \\
& \quad-\sum_{k=1}^{j} k \alpha_{r-(t-k d)}^{k}\left(\sum_{\substack{j-k}}^{j}(-1)^{\ell} \sum_{\substack{i_{1}+\ldots+i_{i}=j-k, 0 \leq u_{\ell} \leq \ldots \leq u_{1} \leq t-j d}} \prod_{a=1}^{\ell} i_{a} \alpha_{r-\left(j-k-i_{1}-\ldots-i_{a}\right) d-u_{a}}^{i_{a}}\right)
\end{aligned}
$$

and, since

$$
r-(t-k d)=r-(j-k) d-(t-j d)
$$

this is exactly the right-hand side appearing in the statement above with $i=t$.

Corollary 12. For $1 \leq j \leq\left\lfloor\frac{r}{d}\right\rfloor$ we have

$$
\operatorname{Coeff}\left(\mathbf{H}^{\star r+1}, q^{j} \mathbf{H}^{\star r+1-j d}\right)
$$

(6) $=\sum_{\ell: 1 \leq \ell \leq j}(-1)^{\ell+1} \sum_{\substack{\left(i_{1}, \ldots, i_{\ell}\right) \in \mathbb{Z}_{\geq 1}: \\ i_{1}+\ldots+i_{\ell}=j}} \sum_{\substack{\left(u_{1}, \ldots, u_{\ell}\right) \in\left(\mathbb{Z}_{\geq 0}\right)^{\times \ell}: \\ 0 \leq u_{\ell} \leq \ldots \leq u_{1} \leq r+1-j d}} \prod_{a=1}^{\ell} i_{a} \alpha_{r-\left(j-i_{1}-\ldots-i_{a}\right) d-u_{a}}^{i_{a}}$.

Proof. Proceeding as in the proof of Proposition 11, we write $\mathrm{H}^{\star r+1}=\mathrm{H} \star \mathrm{H}^{\star r}$ and

$$
\mathbf{H}^{\star r}=\mathbf{H}^{r}-\sum_{j=1}^{\left\lfloor\frac{r}{d}\right\rfloor} \operatorname{Coeff}\left(\mathrm{H}^{r}, q^{j} \mathbf{H}^{\star r-j d}\right) q^{j} \mathrm{H}^{\star r-j d}
$$

Since

$$
\mathrm{H} \star \mathrm{H}^{r}=\sum_{k=1}^{\left\lfloor\frac{r+1}{d}\right\rfloor} k \alpha_{k d-1}^{k} q^{k} \mathrm{H}^{r-k d+1}
$$

we have

$$
\begin{aligned}
& \operatorname{Coeff}\left(\mathrm{H}^{\star(r+1)}, q^{j} \mathrm{H}^{\star(r+1-j d)}\right) \\
& =-\quad-\operatorname{Coeff}\left(\mathrm{H}^{r}, q^{j} \mathrm{H}^{\star(r-j d)}\right) \\
& \quad+\sum_{k=1}^{j} k \alpha_{r-(r+1-k d)}^{k} \operatorname{Coeff}\left(\mathrm{H}^{r+1-k d}, q^{j-k} \mathrm{H}^{\star r+1-j d}\right) \\
& =\sum_{1 \leq \ell \leq j}(-1)^{\ell+1} \sum_{\substack{i_{1}+\ldots+i_{\ell}=j, 0 \leq u_{\ell} \leq \ldots \leq u_{1} \leq r-j d}} \prod_{a=1}^{\ell} i_{a} \alpha_{r-\left(j-i_{1}-\ldots-i_{a}\right) d-u_{a}}^{i_{a}} \\
& \quad-\sum_{k=1}^{j} k \alpha_{k d-1}^{k} \sum_{1 \leq \ell \leq j-k}(-1)^{\ell+1} \sum_{\substack{u_{1}+\ldots+i_{\ell}=j-k, 0 \leq u_{\ell} \leq \ldots \leq u_{1} \leq r+1-j d}} \prod_{a=1}^{\ell} i_{a} \alpha_{r-\left(j-k-i_{1}-\ldots-i_{a}\right) d-u_{a}}^{i_{a}}
\end{aligned}
$$

for $j=1, \ldots,\left\lfloor\frac{r}{d}\right\rfloor$. Finally, since $k d-1=r-(j-k) d-(r+1-j d)$, we are done.

## 3. Proof of the main theorem

### 3.1. Plan of the proof

In this subsection we explain how the proof of Theorem 5 goes.
Define

$$
\Gamma:=\sum_{j: \gamma_{j} \in H^{r}(X)^{\text {prim }}} \gamma_{j}^{\vee} \star \gamma_{j}
$$

and

$$
\mathrm{E}^{\prime}:=\mathrm{m}^{-1} \sum_{i=0}^{r} \mathrm{H}^{i} \star \mathrm{H}^{r-i}
$$

Then

$$
\mathrm{E}=\Gamma+\mathrm{E}^{\prime}
$$

So by Lemma 3, we see that $\Gamma \in Q H^{*}(X)^{\text {res }}$.
Using relations 3 and 4 , the proof of Theorem 5 becomes an easy algebraic count (done in Section 3.4) once we know the following two propositions.

Proposition 13. For $j=1, \ldots,\left\lfloor\frac{r}{d}\right\rfloor$ we have

$$
\operatorname{Coeff}\left(\Gamma, q^{j} \mathrm{H}^{\star r-j d}\right)=\mathrm{m}^{-1}(r+1-\chi(X)) \operatorname{Coeff}\left(\mathrm{H}^{\star r+1}, q^{j} \mathrm{H}^{\star r+1-j d}\right) .
$$

The proof is presented in Section 3.2.
Proposition 14. For $j=1, \ldots,\left\lfloor\frac{r}{d}\right\rfloor$ we have

$$
\operatorname{Coeff}\left(\mathrm{E}^{\prime}, q^{j} \mathrm{H}^{\star r-j d}\right)=-\mathrm{m}^{-1}(r-j d+1) \operatorname{Coeff}\left(\mathrm{H}^{\star r+1}, q^{j} \mathrm{H}^{\star r+1-j d}\right)
$$

The proof is presented in Section 3.3.
We remark here that the way we prove Proposition 14 is purely algebraic. It would be interesting to find a more conceptual explanation for this equality.

### 3.2. Computation of $\Gamma$

The proof of Proposition 13 relies on the following preliminary lemma which is very similar to [7, Lemma 5.2].

Lemma 15. Let $\Lambda \in Q H^{*}(X)^{\text {res }}$ be a degree $2 r$ class such that

$$
\Lambda=a \mathbf{H}^{r} \bmod q \text { and } \mathrm{H} \star \Lambda=0
$$

where $a \in \mathbb{Q}$. Then

$$
\operatorname{Coeff}\left(\Lambda, q^{j} \mathrm{H}^{\star r-j d}\right)=-a \operatorname{Coeff}\left(\mathrm{H}^{\star r+1}, q^{j} \mathrm{H}^{r+1-j d}\right)
$$

for $i=1, \ldots,\left\lfloor\frac{r}{d}\right\rfloor$.

Proof. Write

$$
\Lambda=a \mathbf{H}^{\star r}+\sum_{i=1}^{\left\lfloor\frac{r}{d}\right\rfloor} \operatorname{Coeff}\left(\Lambda, q^{i} \mathbf{H}^{\star r-i d}\right) q^{i} \mathbf{H}^{\star r-i d}
$$

Then we have

$$
0=\mathrm{H} \star \Lambda=a \mathrm{H}^{\star r+1}+\sum_{i=1}^{\left\lfloor\frac{r}{d}\right\rfloor} \operatorname{Coeff}\left(\Lambda, q^{i} \mathbf{H}^{\star r-i d}\right) q^{i} \mathrm{H}^{\star r+1-i d}
$$

from which we obtain the lemma.
Proof of Proposition 13. By [7, Corollary 5.3] (the proof of that corollary also applies when $|\mathrm{m}|=r+L$ ), we have $\mathrm{H} \star \Gamma=0$. Moreover

$$
\Gamma=\sum_{j: \gamma_{j} \in H^{r}(X)^{\text {Prim }}} \gamma_{j}^{\vee} \cup \gamma_{j}=\operatorname{dim}\left(H^{r}(X)^{\text {prim }}\right)(-1)^{r} \mathrm{~m}^{-1} \mathrm{H}^{r} \bmod q
$$

Note that we have $\operatorname{dim}\left(H^{r}(X)^{\text {prim }}\right)=(-1)^{r}(\chi(X)-r-1)$. The proposition now follows from an application of Lemma 15.

### 3.3. Computation of $E^{\prime}$

In this subsection we prove Proposition 14 by showing the following equivalent result:

Lemma 16. For $j=1, \ldots,\left\lfloor\frac{r}{d}\right\rfloor$ we have $\sum_{i=0}^{r} \operatorname{Coeff}\left(\mathrm{H}^{i} \star \mathrm{H}^{r-i}, q^{j} \mathrm{H}^{\star(r-j d)}\right)=-(r-j d+1)$ times the RHS of Equation 6.

Proof. For $0 \leq i \leq r$ and $1 \leq j \leq\left\lfloor\frac{r}{d}\right\rfloor$ we have

$$
\begin{aligned}
& \operatorname{Coeff}\left(\mathrm{H}^{i} \star \mathrm{H}^{r-i}, q^{j} \mathrm{H}^{\star(r-j d)}\right) \\
& \quad=\sum_{(h, s) \in \mathbb{Z}_{\geq 0}^{\times 2}: h+s=j} \operatorname{Coeff}\left(\mathrm{H}^{i}, q^{h} \mathrm{H}^{\star(i-h d)}\right) \operatorname{Coeff}\left(\mathrm{H}^{r-i}, q^{s} \mathrm{H}^{\star(r-i-s d)}\right)
\end{aligned}
$$

and for each $(h, s)$ as above such that $h d \leq i$ and $r-i \geq s d$, the product

$$
\operatorname{Coeff}\left(\mathrm{H}^{i}, q^{h} \mathrm{H}^{\star(i-h d)}\right) \operatorname{Coeff}\left(\mathrm{H}^{r-i}, q^{s} \mathrm{H}^{\star(r-i-s d)}\right)
$$

is equal to

$$
\sum_{\substack{1 \leq w \leq h \\ 1 \leq z \leq s}}(-1)^{w+z} \sum_{\substack{y_{1}+\ldots+y_{w}=h \\ x_{1}+\ldots+x_{z}=s}} \sum_{\substack{0 \leq v_{z} \leq \ldots \leq v_{z} \leq \ldots \leq p_{1} \leq r-h d \\ 0 \leq i-s d}} \prod_{a=1}^{w} i_{a} \alpha_{r-\left(h-y_{1}-\ldots-y_{a}\right) d-p_{a}}^{i_{a}}
$$

$$
\begin{equation*}
\times \prod_{b=1}^{z} x_{b} \alpha_{r-\left(s-x_{1}-\ldots-x_{b}\right) d-v_{b}}^{x_{b}} . \tag{7}
\end{equation*}
$$

Note that it could be that $h=0$ or $s=0$ (but not $h=s=0$, since $h+s=j>0$ ). Observe the symmetry

$$
\alpha_{r-\left(s-x_{1}-\ldots-x_{b}\right) d-v_{b}}^{x_{b}}=\alpha_{\left(s-x_{1}-\ldots-x_{b-1}\right) d+v_{b}-1}^{x_{b}}
$$

and that

$$
\left(s-x_{1}-\ldots-x_{b-1}\right) d+v_{b}-1=r-\left[\left(j-x_{b}-\ldots-x_{z}\right) d+r-v_{b}+1-j d\right]
$$

where $r-v_{b}+1-j d$ varies in $[i-h d+1, r+1-j d]$ for $0 \leq v_{b} \leq r-i-s d$. Therefore we can rewrite the quantity in Equation 7 as

$$
\sum_{\substack{1 \leq w \leq h \\ 1 \leq z \leq s}}(-1)^{w+z} \sum_{\substack{y_{1}+\ldots+y_{w}=h \\ x_{1}+\ldots+x_{z}=s}} \sum_{\substack{0-h \leq p_{w} \leq \ldots \leq p_{1} \leq i \leq h d \\ i \leq v_{1} \leq \ldots \leq v_{z} \leq r+1-j d}} \prod_{a=1}^{w} i_{a} \alpha_{r-\left(h-y_{1}-\ldots-y_{a}\right) d-p_{a}}^{i_{a}}
$$

$$
\begin{equation*}
\times \prod_{b=1}^{z} x_{b} \alpha_{r-\left(j-x_{b}-\ldots-x_{z}\right) d-v_{b}}^{x_{b}} \tag{8}
\end{equation*}
$$

Note that the quantity $i-h d$ appearing in Equation 8 under the third summation symbol varies in $[0, r-j d]$ and not in $[0, r]$ (if $i-h d>r-j d$, then $r-i<(j-h) d=s d$ and so $\left.\operatorname{Coeff}\left(\mathrm{H}^{r-i}, q^{s} \mathrm{H}^{\star(r-i-s d)}\right)=0\right)$.

Fix $j \in\left\{1, \ldots,\left\lfloor\frac{r}{d}\right\rfloor\right\}$ and let $\ell,\left(i_{1}, \ldots, i_{\ell}\right)$ and $\left(u_{1}, \ldots, u_{\ell}\right)$ be such that

$$
0 \leq \ell \leq j, i_{1}+\ldots+i_{\ell}=j \quad \text { and } \quad 0 \leq u_{\ell} \leq \ldots \leq u_{1} \leq r+1-j d
$$

We want to count how many times the term

$$
\begin{equation*}
(-1)^{\ell} \prod_{a=1}^{\ell} i_{a} \alpha_{r-\left(j-i_{1}-\ldots-i_{a}\right) d-u_{a}}^{i_{a}} \tag{9}
\end{equation*}
$$

appears in

$$
\begin{aligned}
b_{j} & :=\sum_{i=0}^{r} \operatorname{Coeff}\left(\mathrm{H}^{i} \star \mathrm{H}^{r-i}, q^{j} \mathrm{H}^{\star(r-j d)}\right) \\
& =\sum_{i=0}^{r} \sum_{h+s=j} \operatorname{Coeff}\left(\mathrm{H}^{i}, q^{h} \mathrm{H}^{\star(i-h d)}\right) \operatorname{Coeff}\left(\mathrm{H}^{r-i}, q^{s} \mathrm{H}^{\star(r-i-s d)}\right) .
\end{aligned}
$$

We observe that $w+z=\ell$ and $\left(x_{z}, \ldots, x_{1}, y_{1}, \ldots, y_{w}\right)=\left(i_{1}, \ldots, i_{\ell}\right)$ must hold. Moreover, given any integer $g \in[0, r-j d]$, if $i-h d=g$ then in Equation 8 we must have

$$
z=\min \left\{f: u_{f} \leq g\right\}-1 \quad \text { and } \quad w=\ell-z
$$

where if $\left\{f: u_{f} \leq g\right\}=\varnothing$, we set $z=\ell$ and $w=\ell$.
Therefore

$$
v_{z}=u_{1}, \ldots, v_{1}=u_{z}, p_{1}=u_{z+1}, \ldots, p_{w}=u_{\ell}
$$

and

$$
x_{z}=i_{1}, \ldots, x_{1}=i_{z}, y_{1}=i_{z+1}, \ldots, y_{w}=i_{\ell}
$$

and finally

$$
h=y_{1}+\ldots+y_{w} \quad \text { and } \quad s=x_{1}+\ldots+x_{z} .
$$

This means that the term in Equation 9 appears in $b_{j}$ once for every $g \in[0, r-j d]$, and thus a total of $r-j d+1$ times. This concludes the proof of the lemma.

### 3.4. Computation of $E$

We finally prove Theorem 5. We will distinguish two cases.

- Case $|\mathrm{m}| \leq r+L-1$.

By Relation 3, in this case we have

$$
\operatorname{Coeff}\left(\mathrm{H}^{\star r+1}, q^{j} \mathrm{H}^{\star r+1-j d}\right)=0 \text { for } j>1 \quad \text { and } \quad \operatorname{Coeff}\left(\mathrm{H}^{\star r+1}, q \mathrm{H}^{\star r+1-d}\right)=\mathrm{m}^{\mathrm{m}} .
$$

Therefore, by Propositions 13 and 14, we have

$$
\begin{aligned}
& \operatorname{Coeff}\left(\mathrm{E}, q^{j} \mathbf{H}^{\star r-j d}\right)=0 \text { for } j>1 \quad \text { and } \\
& \text { Coeff }\left(\mathrm{E}, q \mathrm{H}^{\star r-d}\right)=\mathrm{m}^{m-1}(r+L+1-|\mathrm{m}|-\chi(X))
\end{aligned}
$$

This is what we wanted to prove.

- Case $|\mathrm{m}|=r+L$.

Note that in this case $d=1$. Relation 4, can be rewritten as

$$
\operatorname{Coeff}\left(\mathbf{H}^{\star r+1}, q^{j} \mathbf{H}^{\star r+1-j}\right)=\binom{r}{j-1}(\mathrm{~m}!)^{j-1}\left[\mathrm{~m}^{\mathrm{m}}-\frac{\mathrm{m}!}{j}(r+1)\right]
$$

for $j=1, \ldots, r+1$. Therefore for $j=1, \ldots, r$ we have

$$
\begin{aligned}
\operatorname{Coeff}\left(\mathrm{E}, q^{j} \mathrm{H}^{\star r-j}\right) & =\mathrm{m}^{-1}(j-\chi(X)) \operatorname{Coeff}\left(\mathrm{H}^{\star r+1}, q^{j} \mathrm{H}^{\star r+1-j}\right) \\
& =\mathrm{m}^{-1}(j-\chi(X))\binom{r}{j-1}(\mathrm{~m}!)^{j-1}\left[\mathrm{~m}^{\mathrm{m}}-\frac{\mathrm{m}!}{j}(r+1)\right] .
\end{aligned}
$$

This concludes the proof.

## 4. Virtual Tevelev degrees

We now apply our computations to prove Theorem 10. We distinguish two cases again.

- Case $|\mathrm{m}| \leq r+L-1$.

This case follows from [7, Proposition 5.16] and Theorem 5 above.

- Case $|\mathrm{m}|=r+L$.

The first step is to express E in terms of the basis $1, \mathrm{H}+\mathrm{m}!q, \ldots,(\mathrm{H}+\mathrm{m}!q)^{\star r}$. This will use the following simple combinatorial lemma.

Lemma 17. For $j=2, \ldots, r$ the following two equalities hold:

$$
\begin{equation*}
\sum_{i=1}^{j}\binom{r}{i-1}\binom{r-i}{j-i}(-1)^{j-i}=1 \tag{10}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{i=1}^{j} i\binom{r}{i-1}\binom{r-i}{j-i}(-1)^{j-i}=r+1 \tag{11}
\end{equation*}
$$

Proof. The proof is left to the reader.
Lemma 18. We have

$$
\begin{aligned}
\mathrm{E}= & \mathrm{m}^{-1} \chi(X)(\mathrm{H}+\mathrm{m}!q)^{\star r}+\left[\mathrm{m}^{-1}(r+1-\chi(X))\left(\mathrm{m}^{\mathrm{m}}-\mathrm{m}!\right)-\mathrm{m}^{\mathrm{m}-1} r\right] q(\mathrm{H}+\mathrm{m}!q)^{\star r-1} \\
& +\sum_{j=2}^{r}\left[\mathrm{~m}^{-1}(\mathrm{~m}!)^{j-1}(r+1-\chi(X))\left(\mathrm{m}^{\mathrm{m}}-\mathrm{m}!\right)\right] q^{j}(\mathrm{H}+\mathrm{m}!q)^{\star r-j} .
\end{aligned}
$$

Proof. This is an algebraic check substituting

$$
\mathrm{H}=(\mathrm{H}+\mathrm{m}!q)-\mathrm{m}!q
$$

in the expression of $E$ found in Theorem 5.
Here we will deal with $\operatorname{Coeff}\left(\mathrm{E}, q^{j}(\mathrm{H}+\mathrm{m}!q)^{\star r-j}\right)$ for $j=2, \ldots, r$. The cases $j=0,1$ are instead left to the reader.

Using Theorem 5, we see that for $j=2, \ldots, r$ the coefficient $\operatorname{Coeff}\left(\mathrm{E}, q^{j}(\mathrm{H}+\right.$ $\mathrm{m}!q)^{\star r-j}$ ) is equal to

$$
\mathrm{m}^{-1} \chi(X)\binom{r}{j}(-1)^{j}(\mathrm{~m}!)^{j}
$$

$$
+\sum_{i=1}^{j} \mathrm{~m}^{-1}(i-\chi(X))\binom{r}{i-1}(\mathrm{~m}!)^{i-1}\left[\mathrm{~m}^{\mathrm{m}}-\mathrm{m}!\frac{(r+1)}{i}\right]\binom{r-i}{j-i}(-1)^{j-i}(\mathrm{~m}!)^{j-i}
$$

which we now rewrite as a sum of four terms. The first one is

$$
\begin{aligned}
& \mathrm{m}^{-1} \chi(X)(\mathrm{m}!)^{j-1} \mathrm{~m}!\left[(-1)^{j}\binom{r}{j}+\sum_{i=1}^{j}(-1)^{j-i}\binom{r}{i-1}\binom{r-i}{j-i} \frac{r+1}{i}\right] \\
& \quad=\mathrm{m}^{-1} \chi(X)(\mathrm{m}!)^{j-1} \mathrm{~m}!
\end{aligned}
$$

where we used Equation 10. The second one is

$$
-\mathrm{m}^{-1} \chi(X)(\mathrm{m}!)^{j-1} \mathrm{~m}^{\mathrm{m}} \sum_{i=1}^{j}\binom{r}{i-1}\binom{r-i}{j-i}(-1)^{j-i}=-\mathrm{m}^{-1} \chi(X)(\mathrm{m}!)^{j-1} \mathrm{~m}^{\mathrm{m}}
$$

where we used Equation 10. The third term is

$$
-\mathrm{m}^{-1}(\mathrm{~m}!)^{j-1} \mathrm{~m}!\sum_{i=1}^{j}\binom{r}{i-1}\binom{r-i}{j-i}(-1)^{j-i}(r+1)=-\mathrm{m}^{-1}(\mathrm{~m}!)^{j-1} \mathrm{~m}!(r+1)
$$

where we used again Equation 10. Finally the last term is

$$
\mathrm{m}^{-1}(\mathrm{~m}!)^{j-1} \mathrm{~m}^{\mathrm{m}} \sum_{i=1}^{j} i\binom{r}{i-1}\binom{r-i}{j-i}(-1)^{j-i}=\mathrm{m}^{-1}(\mathrm{~m}!)^{j-1} \mathrm{~m}^{\mathrm{m}}(r+1)
$$

where instead we used Equation 11.
Summing everything up we obtain the desired conclusion.
Although the full expression of E might be a bit complicated, the product $(\mathrm{H}+\mathrm{m}!q)^{\star r} \star \mathrm{E}$ is quite simple.

Corollary 19. We have

$$
(\mathrm{H}+\mathrm{m}!q)^{\star r} \star \mathrm{E}=\left[\mathrm{m}^{-1}-\mathrm{m}^{-r \mathrm{~m}-1}(\mathrm{~m}!)^{r}(r+1-\chi(X))\right](\mathrm{H}+\mathrm{m}!q)^{\star 2 r} .
$$

Proof. Use $r$ times Equality 4.
We can now finish the proof of Theorem 10.
Proof of Theorem 10 when $|\mathrm{m}|=r+L$. From Definition 8 and Equation 4, we see that

$$
\begin{equation*}
\mathrm{P}^{\star n} \star \mathrm{E}^{\star g} \star(\mathrm{H}+\mathrm{m}!q)^{\star r}=\left(\sum_{i=0}^{r} b_{i} \mathrm{~m}^{-(k+i) \mathrm{m}}\right)(\mathrm{H}+q \mathrm{~m}!)^{\star r+r g+n r} . \tag{12}
\end{equation*}
$$

Using Definition 8 and Equation 4, we also have

$$
\mathrm{P}^{\star n} \star(\mathrm{H}+\mathrm{m}!q)^{\star r}=\left(\sum_{i=0}^{r} P_{i} \mathrm{~m}^{-i \mathrm{~m}}\right)^{n}(\mathrm{H}+q \mathrm{~m}!)^{\star n r+r},
$$

and so by Corollary 19

$$
\begin{align*}
\mathrm{P}^{\star n} & \star \mathrm{E}^{\star g} \star(\mathrm{H}+\mathrm{m}!q)^{\star r} \\
& =\left(\sum_{i=0}^{r} P_{i} \mathrm{~m}^{-i \mathrm{~m}}\right)^{n}\left(\mathrm{~m}^{-1}-\mathrm{m}^{-r \mathrm{~m}-1}(\mathrm{~m}!)^{r}(r+1-\chi(X))\right)^{g}(\mathrm{H}+\mathrm{m}!q)^{\star r+g r+n r} . \tag{13}
\end{align*}
$$

The theorem follows by comparing Equation 12 and Equation 13.

## 5. An algorithm for the calculation of the coefficients $\boldsymbol{P}_{\boldsymbol{i}}$

In this final section we propose a method to compute the coefficients $P_{i}$ appearing in Definition 8. In this way, up to implementing the algorithm with a computer, all the virtual Tevelev degrees of $X$ can be explicitly calculated.

It is possible that our result is known to the experts, but we preferred to include it anyway for completeness.

### 5.1. Recursion for genus 0 two-pointed Hyperplane Gromov-Witten invariants

Proposition 11 reduces the computation of the $P_{i}$ 's to the computation of genus 0 two-pointed Hyperplane Gromov-Witten invariants of $X$. These invariants satisfies a recursion involving more general integrals which we now recall.

### 5.1.1. The recursion

For $g \geq 0, k>0$ and $n>0$ the gravitational descendant invariants of $X$ are defined by:

$$
\left\langle\tau_{a_{1}}\left(\gamma_{1}\right), \ldots, \tau_{a_{n}}\left(\gamma_{n}\right)\right\rangle_{g, k}^{X}:=\int_{\left[\overline{\mathcal{M}}_{g, n}(X, k \mathrm{~L})\right]^{\mathrm{vir}}} \operatorname{ev}_{1}^{*}\left(\gamma_{1}\right) \cup \psi_{1}^{a_{1}} \cup \ldots \cup \operatorname{ev}_{n}^{*}\left(\gamma_{n}\right) \cup \psi_{n}^{a_{n}}
$$

where $\gamma_{1}, \ldots, \gamma_{n} \in H^{*}(X)$ and $\psi_{i}=c_{1}\left(\mathbb{L}_{i}\right) \in H^{2}\left(\overline{\mathcal{M}}_{g, n}(X, k \mathrm{~L})\right)$ is the first Chern class of the cotangent line

$$
\left.\mathbb{L}_{i}\right|_{\left[f:\left(C, p_{1}, \ldots, p_{n}\right) \rightarrow X\right]}=\left(T_{p_{i}} C\right)^{\vee}
$$

for $i=1, \ldots, n$.
We start with a monodromy result.

Lemma 20. For any $\gamma \in H^{*}(X)^{\text {prim }}, \gamma_{1}, \ldots, \gamma_{n} \in H^{*}(X)^{\text {res }}($ with $n \geq 0), a_{1}, \ldots$, $a_{n} \in \mathbb{Z}_{\geq 0}$ and $k>0$ we have

$$
\left\langle\tau_{a_{1}}\left(\gamma_{1}\right), \ldots, \tau_{a_{n}}\left(\gamma_{n}\right), \gamma\right\rangle_{0, k}^{X}=0
$$

Proof. The proof is a monodromy argument. Let

$$
U \subset \prod_{i=1}^{L} \mathbb{P}\left(H^{0}\left(\mathbb{P}^{r+L}, \mathcal{O}\left(m_{i}\right)\right)\right)
$$

be the open subscheme parametrizing smooth complete intersection in $\mathbb{P}^{r+L}$ of dimension $r$ and degree $m$. Call $V=V^{\text {prim }} \oplus V^{\text {res }}$ where $V^{\text {prim }}=H^{*}(X)^{\text {prim }} \otimes_{\mathbb{Q}} \mathbb{R}$ and $V^{\mathrm{res}}=H^{*}(X)^{\mathrm{res}} \otimes_{\mathbb{Q}} \mathbb{R}$, and

$$
\rho: \pi_{1}(U, u) \longrightarrow \operatorname{Aut}(V)
$$

the monodromy homomorphism (here $u \in U$ is the point corresponding to $X$ ). The homomorphism $\rho$ preserves the decomposition $V=V^{\text {prim }} \oplus V^{\text {res }}$ and actually its invariant subspace is exactly $V^{\text {res }}$. Let $G \subset \mathrm{GL}\left(V^{\text {prim }}\right)$ be the algebraic monodromy group defined as the Zariski closure of the image of $\pi_{1}(U, u) \rightarrow \operatorname{Aut}\left(V^{\text {prim }}\right)$. The lemma will follow from the following two standard facts:

- the invariance under deformations of $X$ in Gromov-Witten theory tells us that for any $\alpha \in \pi_{1}(U, u)$ we have:

$$
\left\langle\tau_{a_{1}}\left(\alpha \cdot \gamma_{1}\right), \ldots, \tau_{a_{n}}\left(\alpha \cdot \gamma_{n}\right), \alpha \cdot \gamma\right\rangle_{0, k}^{X}=\left\langle\tau_{a_{1}}\left(\gamma_{1}\right), \ldots, \tau_{a_{n}}\left(\gamma_{n}\right), \gamma\right\rangle_{0, k}^{X}
$$

- the intersection form $Q$ on $V^{\text {prim }}$ is preserved by the monodromy action. When $r$ is odd, $Q$ is a non-degenerate skew-symmetric bilinear form, it follows that in this case $\operatorname{dim}\left(V^{\text {prim }}\right)$ is even and that $G \subseteq \operatorname{Sp}\left(V^{\text {prim }}\right)$. When instead $r$ is even, $Q$ is a non-degenerate symmetric bilinear form and we have $G \subseteq \mathrm{O}\left(V^{\text {prim }}\right)$. Since for us $r \geq 3$, by [12, Theorem 4.4.1] (see also [1, Proposition 4.2]), the previous inclusions are actually equalities except for the case when $r$ is even and $m=(2,2)$. In this latter case, $\operatorname{dim}\left(V^{\text {prim }}\right)=r+3$ and $G$ is the Weyl group $\mathcal{W}$ of $D_{r+3}$.
Since $-\operatorname{Id} \in \operatorname{Sp}\left(V^{\text {prim }}\right)$ and $-\operatorname{Id} \in \mathrm{O}\left(V^{\text {prim }}\right)$ the proof is complete in all cases except for the case $r$ even and $\mathrm{m}=(2,2)$. In this case, note that if $L: V^{\text {prim }} \rightarrow V^{\text {prim }}$ is any $\mathbb{R}$-linear map invariant under $\mathcal{W}$ then $L=0$ must hold (reason: if $\Phi \subset V^{\text {prim }}$ is the root system corresponding to $D_{r+3}$ then for all $v \in \Phi$ the reflection $r_{v}$ along the hyperplane $v^{\perp}$ lies in $\mathcal{W}$ and sends $v$ to $-v$, thus $L(v)=L(-v)=-L(v)$, from which $L(v)=0$. Since $\operatorname{Span}_{\mathbb{R}}(\Phi)=V^{\text {prim }}$ we are done). To conclude the proof of the lemma, apply this observation with $L=\left\langle\tau_{a_{1}}\left(\gamma_{1}\right), \ldots, \tau_{a_{n}}\left(\gamma_{n}\right),-\right\rangle_{0, k}^{X}$.

Proposition 21. Let $i, a \geq 0$ and $j, k>0$ be integers satisfying

$$
i+j+a=\operatorname{vdim}\left(\overline{\mathcal{M}}_{0,2}(X, k \mathrm{~L})\right)
$$

Then we have

$$
\begin{aligned}
\left\langle\tau_{a}\left(\mathrm{H}^{i}\right), \mathrm{H}^{j}\right\rangle_{0, k}^{X}= & \left\langle\tau_{a}\left(\mathrm{H}^{i+1}\right), \mathrm{H}^{j-1}\right\rangle_{0, k}^{X}+k\left\langle\tau_{a+1}\left(\mathrm{H}^{i}\right), \mathrm{H}^{j-1}\right\rangle_{0, k}^{X} \\
& -\sum_{\ell=1}^{k-1} \mathrm{~m}^{-1} \ell\left\langle\tau_{a}\left(\mathrm{H}^{i}\right), \mathrm{H}^{\ell d+r-1-i-a}\right\rangle_{0, \ell}^{X}\left\langle\mathrm{H}^{j-1}, \mathrm{H}^{(k-\ell) d+r-j}\right\rangle_{0, k-\ell}^{X} .
\end{aligned}
$$

Proof. An application of [17, Corollary 1] and the splitting principle in GromovWitten theory yields

$$
\begin{aligned}
\left\langle\tau_{a}\left(\mathrm{H}^{i}\right), \mathrm{H}^{j}\right\rangle_{0, k}^{X}= & \left\langle\tau_{a}\left(\mathrm{H}^{i+1}\right), \mathrm{H}^{j-1}\right\rangle_{0, k}^{X}+k\left\langle\tau_{a+1}\left(\mathrm{H}^{i}\right), \mathrm{H}^{j-1}\right\rangle_{0, k}^{X} \\
& -\sum_{\ell=1}^{k-1} \sum_{j=0}^{N} \ell\left\langle\tau_{a}\left(\mathrm{H}^{i}\right), \gamma_{j}^{\vee}\right\rangle_{0, \ell}^{X}\left\langle\mathrm{H}^{j-1}, \gamma_{j}\right\rangle_{0, k-\ell}^{X}
\end{aligned}
$$

where as always $\left\{\gamma_{j}\right\}_{j=0}^{N}$ is any homogeneous basis of $H^{*}(X)$ with $\gamma_{0}=1$ and $\gamma_{N}=\mathrm{P}$. Finally, apply Lemma 20 to conclude the proof.

### 5.1.2. The base case

Consider the recursion of Proposition 21. In each two-pointed Gromov-Witten integral on the right-hand side, either the quantity $j$ decreased or the quantity $k$ decreased (when compared to those appearing in the left-hand side). Note also that when $k=1$, the recursion becomes simply

$$
\left\langle\tau_{a}\left(\mathrm{H}^{i}\right), \mathrm{H}^{j}\right\rangle_{0,1}^{X}=\left\langle\tau_{a}\left(\mathrm{H}^{i+1}\right), \mathrm{H}^{j-1}\right\rangle_{0,1}^{X}+\left\langle\tau_{a+1}\left(\mathrm{H}^{i}\right), \mathrm{H}^{j-1}\right\rangle_{0,1}^{X} .
$$

So, when $k=1, k$ stabilizes while $j$ continues to decrease. It follows that the recursion completely determines all the integrals

$$
\left\langle\tau_{a}\left(\mathrm{H}^{i}\right), \mathrm{H}^{j}\right\rangle_{0, k}^{X} \text { for } a, i, j \geq 0 \text { such that } a+i+j=\operatorname{vdim}\left(\overline{\mathcal{M}}_{0,2}(X, k \mathrm{~L})\right)
$$

once the integrals $\left\langle\tau_{a}\left(\mathrm{H}^{i}\right), 1\right\rangle_{0, k}^{X}$ are given for all $a, i \geq 0$ and $k>0$. These last invariants are indeed known as the next proposition shows.

Proposition 22. Let $a, i \geq 0$ and $k>0$ be integers such that

$$
a+i=\operatorname{vdim}\left(\overline{\mathcal{M}}_{0,2}(X, k \mathrm{~L})\right) .
$$

Then

- for $|\mathrm{m}| \leq r+L-1$ and $i=0, \ldots, r$ we have

$$
\left\langle\tau_{r+k d-1-i}\left(\mathrm{H}^{i}\right), 1\right\rangle_{0, k}^{X}=\operatorname{Coeff}\left(\frac{\prod_{j=1}^{L} \prod_{\ell=0}^{k m_{j}}\left(m_{j} x+\ell\right)}{\prod_{\ell=1}^{k}(x+\ell)^{r+L+1}}, x^{r+L-i}\right)
$$

- for $|\mathrm{m}|=r+L$ and $i=0, \ldots, r$ we have

$$
\left\langle\tau_{r+k-1-i}\left(\mathrm{H}^{i}\right), 1\right\rangle_{0, k}^{X}=\sum_{h=0}^{k} \frac{(-\mathrm{m}!)^{k-h}}{(k-h)!} \operatorname{Coeff}\left(\frac{\prod_{j=1}^{L} \prod_{\ell=0}^{h m_{j}}\left(m_{j} x+\ell\right)}{\prod_{\ell=1}^{h}(x+\ell)^{r+L+1}}, x^{r+L-i}\right)
$$

where in both cases the coefficient of $x^{r+L-i}$ is meant to be the coefficient of the Taylor expansion in $x$ at 0 .

Proof. This is just a way of rephrasing [6, Theorem 4.2 and Theorem 4.17]. Note that in [6, Theorem 4.17] there is a typo: in their notation, their index $m$ in the product appearing in the numerator should range from 0 to $d l_{j}$, instead of from 1 to $d$.
